Third Quarter 2008 Summary Results

Net revenue: Revenue remained consistent with the second quarter (increased 3 percent on a year over year) at \$3.1 billion.

Core Operating Income*: Increased 26 percent sequentially (decreased 2 percent on a year over year) to \$85.3 million.

Core Earnings Per Diluted Share*: Increased 30 percent sequentially (increased 13 percent on a year over year) to \$0.26.

* Core operating income and core EPS excludes amortization of intangibles, stock-based compensation expense and related charges, acquisition-related charges, restructuring and impairment charges and other income/loss.

Fourth Quarter 2008 Guidance

Core EPS* is estimated to be in a range of \$1.11 to \$1.15 per diluted share for the fiscal year.
